General changes: "guns" >> "firearms"; "trustee" >> "director"; "Board" >> "Board of Directors"; and bringing the bylaws into conformity with actual practice.

# Article 1 Name - unchanged

# **Article 2 Purpose and Objectives -**

- 1. Clarified focus to shooting and archery
- 2. Other starts with fishing
- 4. "youth" scholarship program vs "scholarship program"

# **Article 3 Membership -**

- A.1.d (membership classifications) "handicap" shifted to "disabled," and clarified from original wording.
- B.1.e added, "Membership on Club committees, and standing for election as a Club Director."
- C: Suspension and expulsion clarified, and introduces the Special Membership Meeting in place of General Meeting.

### **Article 4 Dues and Assessments -**

Section A: Dues and fees - major change to reflect current practice. Board of directors, not BISC members, vote on annual dues and fees.

Section B: Assessments - major change to reflect current practice. BOD, not BISC members vote on assessments.

### **Article 5 Meetings -**

Section A: Meetings and notifications

A.1. Four meetings are listed.

A.2-5 AGM, SMM, Regular BOD, Special BOD meeting details are presented.

A.6-7 Notice and nature of meetings (in-person, virtual) is modernized.

Section B: Quorum and voting by proxy or electronic means - updated

#### Article 6 Nominations and Elections -

Steps are streamlined from current cumbersome processes. The Vice President is assigned preliminary responsibility for executing the nomination and election process.

# Article 7 Board of Directors and Board Officers - major change

Membership elects Directors (not Trustees) who in turn elect amongst themselves Board Officers.

Director responsibilities are carefully delineated (A.5), and all officers will also be directors. Section 7.B clarifies roles and responsibilities.

Section 7.A.4 presents a detailed transition between current board membership (10) and terms and the new board membership (9) and its terms.

Section 7.C: Continuity and Financial Oversight - major change to reflect current practice. BOD oversees all expenses, and membership does not vote on them. Expense limits are not specified.

Section 7.D: Terms and Filling Board of Directors Vacancies - updated and

aligned with restructuring.

Section 7.E (new) addresses the suspension and expulsion of officers on the board (Board-elected) and Directors within the Board (member-elected)

## Article 8 Committees, Managers, and Operational Roles -

Section 4 - Articulates that "...committee chair and Range Manager will prepare and submit to the Board Treasurer a written annual budget containing expected revenues, expected expenses, expected capital expenditures and any extraordinary expenses for the coming year." (New)

Section 6 - CRSO - description, function, duties expanded

Section 7 - RSO - retains authorization of RSOs on "another range" with the Board of Directors and not the CRSO.

# Article 9 Intoxicating Substances - no change

#### **Article 10 Amendments and Revisions -**

Sections 1 and 2 are consolidated in the new section 1 for clarity.

#### Article 11 Loans -

Sections 1 and 2 are merged and consolidated.

### Article 12 Relocation or Dissolution -

Section 10 added to "cover" restricted funds such as those associated with the PCR.

**Article 13 Conflict of Interest** - substantially consolidated and reduced. Details that comprised over two pages of the original bylaws are suggested to be included in a Board Policy adopted by resolution if desired.
