Release, Waiver, Indemnification, Hold Harmless and Risk Assumption Agreement

I, _____ (*PRINT FULL NAME*) understand that participating in or viewing archery and shooting sports is potentially hazardous, and certain risks are involved in participating or viewing each of these activities. These potential hazards include, but are not limited to, gun shot or archery wounds and can result in paralysis, loss of vision, hearing, limb or life.

In return for access to and/or use of the BISC range(s), buildings, and land (hereinafter referred to as the "Premises"), instruction or for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I (or on behalf of my child/ward or children if I am executing this agreement with respect to such child/ward or children) agree to the following:

1. To indemnify, hold harmless and defend the BISC, and its volunteers, directors, officers, employees or agents, from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with viewing or taking part in activities on the Premises which include, but are not limited to, archery, the discharge of firearms, course(s) of instruction; my presence on or use of the Premises; and any and all acts or omissions.
2. Indemnify, hold harmless and defend BISC, from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against BISC, whether individually, jointly, or in solido with me, together with all court costs and other costs or expenses arising out of or incurred in connection with any such claim, demand or lawsuit, including attorney's fees.
3. Waive for myself and/or my child/ward and for my executors, administrators, assignees and heirs, any and all rights and claims for damages, losses, demands and any other actions whatsoever, which I may have or which may arise against BISC, (including, but not limited to any and all injuries, damages illnesses or death suffered by myself or my property), which may, in any way whatsoever, arise out of, be related to or be connected with the Premises, including any latent defect in the Premises; my presence on or use of said Premises; my property (whether or not entrusted to BISC); and the discharge of firearms. BISC shall not be liable for, and I, on behalf of myself and my executors, administrators, assignees or heirs, hereby expressly release BISC from any and all such claims.
4. Expressly assume the risk of entering the Premises and of taking part in activities on the Premises which include, but are not limited to, archery, instruction in the use of firearms, the discharge of firearms and the firing of live ammunition.

I further agree that:

- i) My participation in activities at BISC is entirely voluntary, is done so at my own risk and agree that I will not hold BISC liable for any accidents;
- ii) I will at all times abide by all BISC range rules and procedures, and obey the commands given by the Range Safety Officer in Charge;
- iii) Minors (under the age of 18) must at all times be accompanied by or under the supervision of an adult Club member or Guest who is their legal guardian or custodian.
